If you agree that this is the proper amount of just compensation for the taking of the entirety of Tracts RGV-MCS-1022E-1, RGV-MCS-1022E-2, RGV-MCS-1022E-3 and RGV-MCS-1022E-4, the United States requests that you review the enclosed proposed unsworn declaration. If you agree that the statements contained in the proposed unsworn declaration are factually accurate as to you, the United States requests that you: (a) print your name in the first line of Paragraph (1), (b) print the month and day on which you are executing the declaration, (c) sign where indicated, (d) print your name below the signature line where indicated, and (e) return the executed declaration to the undersigned by mail using the enclosed stamped addressed envelope on or before February 13, 2017.

Also, if you determine that you do not have an interest in the case or if you will not make a claim for just compensation in this case, we are enclosing a Disclaimer for your consideration to be signed and returned to our office by mail using the enclosed stamped addressed envelope.

A copy of the original Declaration of Taking, as well as, Amendment to Declaration of Taking filed in this case are enclosed so that you may review them both for your information and for consideration of the proposed unsworn declaration. If you have any questions, you may contact either

5. The estate taken is described on Schedule "E" attached hereto and made a part hereof.
6. The sum estimated by the undersigned as just compensation for the land being taken is set forth in Schedule "F" attached hereto and made a part hereof. The undersigned is of the opinion that the ultimate award for said land probably will be within any limits prescribed by law to be paid therefor.

8. The United States made best efforts to negotiate purchase of the property interest sought prior to filing this condemnation action.
